

## **LMU-TAU Research Cooperation Program** **2025 Calls for Applications**

### **Joint Research Projects**

#### **1. Introduction and Purpose**

The “LMU-TAU Research Cooperation Program” is intended to support and promote joint research projects carried out by TAU and LMU research groups. Researchers affiliated with each institution [Principal Investigators (“PIs”)] are invited to jointly submit research proposals for the development of collaborative research projects and the exchange of researchers between TAU and LMU (a “Project”) under the terms and conditions described below.

#### **2. Projects**

- a) Up to four (4) joint projects will be selected by means of a call for applications issued jointly by the two institutions.
- b) To be eligible under the program, a project must include research team participants from both institutions. Eligibility to serve as the person responsible for the scientific and scholarly conduct of a project (the PI) will be determined in accordance with the policies and procedures of the relevant institution. Submissions are made jointly by two PIs, one from LMU and one from TAU, each submitting the same proposal for a project to his or her own institution. All proposals will be in English in a standard format as may be agreed by the institutions, including an abstract, detailed budget and CVs of the respective PIs.
- c) The proposals will be assessed and recommended for selection by a committee composed of members from both Institutions. The committee will operate under terms of reference established jointly by the institutions.
- d) Each project will be for one (1) fiscal year (January until December), unless otherwise agreed by the institutions.
- e) The funding provided by the universities is intended to support research expenses such as:
  - Travel and accommodation costs to or in Munich/Tel Aviv
  - Expenses for organizing events (e.g. catering, dissemination material)
  - Research support (e.g. student assistants; at LMU this category exclusively and in particular no E 13/14 TV-L personnel)
  - Publication costs
  - Reasonable research-related consumables and material expenses may also be funded.

#### **3. Value and Funding Principles**

Successful joint proposals will receive up to a maximum of 46,250 euros overall. TAU will provide each approved project up to 23,125 euros, and LMU will provide each approved project up to 23,125 euros, each in support of their respective researchers.

#### **4. Eligibility**

Eligible to submit proposals are TAU and LMU faculty members (at LMU: postdocs and professors employed at LMU on a fixed-hours basis). Collaborators from other institutions besides TAU and LMU are eligible to participate in projects but are not eligible for any financial support from TAU or LMU.

## 5. Intellectual Property

- a) Definitions. In this Call for Applications,
- i. "Background Intellectual Property" means Intellectual Property of a party that is: proprietary to that party and was conceived, created, or developed prior to the execution of this agreement, or will be conceived, created or developed following execution of this agreement independent of, any research performed pursuant to or related to this agreement or a project hereunder; and in each case, that is necessary for the performance of a project.
  - ii. "Foreground Intellectual Property" means Intellectual Property that is discovered, created or reduced to practice in the performance of a project.
  - iii. "Intellectual Property" (or "IP") means all intellectual property, including technical information, know-how, models, drawings, specifications, prototypes, inventions and software.
- b) Ownership
- i. Background Intellectual Property of a party shall remain the exclusive property of such party.
  - ii. LMU shall own all Foreground Intellectual Property created solely by LMU's personnel.
  - iii. TAU shall own all Foreground Intellectual Property created solely by TAU's personnel.
  - iv. Commercialization of Joint IP. Both parties will agree to negotiate in good faith the terms of an inter-institutional agreement through which the Joint IP may be commercialized.

TAU and LMU agree that each party has its own pre-existing proprietary rights that are not affected by this Call for Applications. If TAU personnel and LMU personnel are co-inventors of any result or invention, the parties will negotiate in good faith and enter into an inter-institutional agreement relating to the protection, use and commercialization of such joint result or invention.

## 6. Timeline

Project adjudication: Projects will be reviewed by the TAU and LMU committee members, which will reach a mutual decision based on all votes of the committee members.

Funding period	1 January - 31 December 2025

## 7. Proposal Requirements

Submission to TAU or LMU must be in the form of standard internal grant submissions used by each university respectively, and must adhere to the guidelines listed in this Call for Applications, as follows:

- Title and description of the research project (up to 3 pages), including the expected outcome and outline of the longer-term benefits to both institutions
- Curriculum vitae of the cooperating partners at LMU and TAU (up to two pages each; top five relevant publications only)
- Planned timeline

- List of planned project participants (in particular, name and position/rank of persons for whom travel expenses are to be reimbursed)
- Detailed LMU and TAU budget, including other sources of funding
- List of planned further grant applications and planned publications, if applicable

## 8. Submission of Applications

- a) Applications are prepared and submitted jointly. Each application must be submitted on or before **3 November 2024** to both TAU and LMU by the respective PIs.
- b) No applications will be accepted after the deadline, nor will any addendum or explanation be accepted, unless those explicitly and formally requested by TAU or LMU.

**To Apply:** Joint applications should be submitted to both institutions by each institution's respective PI. TAU scholars should apply using the [Joint Projects](#) online submission form. LMU scholars should apply using the [LMU online submission form](#). Applications submitted by any other means will not be accepted.

## 9. Analysis and Selection

- a) The proposals will be subjected to an administrative review to ensure eligibility and will subsequently be reviewed by way of a competitive process which will evaluate the merit and relevance of the project, the academic excellence of the candidate, the relation of the proposed project to any ongoing research, and the interest of the two institutions. Proposals which do not comply with the terms of the Call for Applications will be considered "not qualified."
- b) The TAU Vice President, International and the LMU program coordinator, or their delegates, will convene a mutual *ad hoc* committee comprised of LMU and of TAU researchers to review, approve, and rank proposals received at their respective institutions. Up to four (4) joint proposals will be selected for funding.
- c) Selection of proposals for funding must be agreed to by both parties.

## 10. Result of the Analysis

Final results will be announced by email to the interested parties.

## 11. Grant Cancellation

TAU and LMU may cancel funding if, during the tenure of the award, one or more facts are deemed serious enough to warrant cancellation, at the discretion of the TAU Vice President International or the TAU program coordinator at LMU.

## **LMU-TAU Research Cooperation Program 2025 Calls for Applications Workshops**

As part of the LMU-TAU Research Cooperation Program, Ludwig-Maximilians-Universität München (LMU) and Tel Aviv University (TAU) support workshops conducted jointly by researchers from both universities.

### **Eligibility**

LMU and TAU faculty members are eligible to submit applications (at LMU: postdocs and professors employed at LMU on a fixed-hours basis). Collaborators from other institutions besides TAU and LMU can participate in the workshops but are not eligible for any financial support from TAU or LMU.

### **Funding**

Successful joint proposals will receive up to a maximum of 15,000 euros overall. TAU will provide each approved project up to 7,500 euros, and LMU will provide each approved project up to 7,500 euros, each in support of their respective researchers. Funding may include the following:

- a) Travel and accommodation costs to or in Munich/Tel Aviv
- b) Expenses for organizing events (e.g. catering, dissemination material)
- c) Research support (e.g. student assistants; at LMU this category exclusively and in particular no E 13/14 TV-L personnel)
- d) Publication costs

The costs of travel and accommodation as well as daily allowance will be reimbursed by both universities in accordance with their own regulations.

- Title and description of the conference (up to 2 pages), including the expected outcome and outline of the longer-term benefits to both institutions
- Curriculum vitae of the cooperating partners at LMU and TAU (up to two pages each; top five relevant publications only)
- Planned timeline
- List of planned project participants (in particular, name and position/rank of persons for whom travel expenses are to be reimbursed)
- Detailed LMU and TAU budget, including other sources of funding
- List of planned further grant applications and planned publications, if applicable

### **Submission of Applications**

Applications for workshops in 2025 should be prepared jointly and submitted to TAU and LMU by **3 November 2024**.

### **Visiting Professorships at LMU Munich**

As part of the Academic Cooperation Program with Tel Aviv University (TAU), the Ludwig-Maximilians-Universität München (LMU) offers visiting professorships to TAU faculty. The professorships are open to all tenure and tenure-track TAU faculty working in research fields, which are also represented at LMU. The duration of each professorship is flexible; it may vary from 3 to 12 months depending on individual needs and interests.

Visiting professors will be given the opportunity to dedicate their time largely to their own research projects and to collaborative projects with LMU faculty. They will be asked to present their current research projects in Munich within LMU-TAU lecture series. Depending on the length of the stay, visiting professors are encouraged to contribute to teaching by means of one of the following options:

- Teaching or co-teaching a class of graduate or postgraduate students
- Participating in an LMU-TAU workshop
- Giving a lecture
- Financial means for inviting doctoral students or colleagues from TAU will be available

The fellowship, travel expenses and research resources for the visiting professor will be covered by LMU. Research costs are expenses contributing to the development of the joint cooperation between LMU and TAU. For instance, hospitality costs at conferences or employment of students' assistants to support the visiting professor.

#### **The selection committee will assess applications based on the following:**

- Proof of contact with a research partner at LMU
- Letter of invitation from the Department Chair at LMU
- Project and course description (2-3 pages)
- Curriculum vitae and list of publications
- Preferred period of stay in 2025 (you are welcome to give more than one option)
- Preferences regarding offering a seminar, workshop, or lecture at LMU

\*Final decision will be made by LMU committee members.

#### **Deadline for submission: 3 November 2024**

Priority will be given to faculty members who can demonstrate the relevance of LMU to their research endeavors and/or those who have established partnerships with scholars at LMU.

### **Research Visits for Postdocs**

As part of the research cooperation between Tel Aviv University (TAU) and Ludwig-Maximilians-Universität München (LMU) postdocs from both universities can apply for funding for a research stay up to three months at the partner university.

#### **Funding**

LMU and TAU postdocs will be given the opportunity to work on their research projects at the partner university for a period of one to three months.

The costs of travel and accommodation as well as daily allowance will be covered by the sending institution up to 3,300 euros per month and reimbursed by both universities in accordance with their own regulations.

#### **Requirements**

- Research project in an intermediate-advanced stage of development
- Postdocs must be employed on a fixed-hour basis at LMU or TAU at the time of application and during the research stay at the partner university

#### **Application Documents**

- Title and short description of the research project (up to 3 pages)
- Preferred period of stay in 2025 giving the number of months
- Detailed information about the research context at LMU and TAU in which the research work will be conducted
- Curriculum vitae
- Letter of recommendation from a professor at LMU or TAU
- Letter of invitation from a professor at LMU or TAU
