The terms of your employment as an adjunct professor will be in accordance with the Regulations for the Appointment and Terms of Employment of Adjunct Professors (5744).

Your role as an adjunct professor will include all the accompanying activities, as accepted for professor teaching positions at the University, including holding regular office hours, offering guidance to students, checking papers and assignments, preparing exam questionnaires, being present at exams, checking exams, participation in coordination meetings and sitting on committees, even if these are performed before and/or after the appointment period, all in relation to the relevant academic year.

The salary paid to you under this letter of appointment will constitute the full consideration paid also for all the aforementioned accompanying activities, and you will not be entitled to any additional consideration for them.

For the avoidance of doubt, it is hereby clarifying that you are not entitled to payment and/or to accumulate rights for a sabbatical, education fund, life insurance, tuition scholarships and phone and car expense returns. However, you will be entitled to a refund of expenses incurred for transportation to and from your place of work (in accordance with the procedures practiced at your institution). You will be entitled to an annual leave in accordance with the Annual Leave Law, 5711-1951, and, as agreed, this will be given to you when the University is in recess, and in any case you will not be entitled to redeem any vacation days you did not use. The obligation to use your vacation days was taken into account when determining the duration of your appointment.

Should the faculty, or the unit in the faculty in which you were appointed, decide, for any reason whatsoever, to terminate or cancel, whether in full or in part, the teaching of the subject for which you have been appointed, the Dean of the Faculty or the Rector, as the case may be, will be allowed to cancel this appointment by providing you an early notice 30 days in advance.
