

EMPH Program in Disaster & Emergency Management Eligibility Criteria for Reduced Fees Scholarship

Candidates for the program will be eligible for a scholarship in the form of reduced tuition fees when they enroll into the program if they hold citizenship <u>and</u> reside in one of the countries listed in the annex.

General terms & conditions:

- The scholarship is fixed on 2,000 USD;
- Only students meeting the above mentioned criterion and who paid all tuition fees (minus 2,000 USD) are eligible for the scholarship;
- If, for any reason, the student will not pay the full tuition fees (minus 2,000 USD) by the time he/she finish their studies in the program, he/she will be regarded as not eligible for the scholarship. Such student will be regarded as if he/she are required to pay the full tuition fees.
- If, for any reason, the student will not complete his/her studies in the program, he/she will have to pay the dropout balance from the full tuition fee, as if they did not receive a scholarship at all.
- The program reserves the right to cancel the scholarship program and/or make any changes in the above mentioned criteria and terms.
